- 1. Use this form only if the Fujitsu Branded Toshiba disk drives were purchased directly from Fujitsu / Toshiba Australia.
 - a. Maximum of 20 items per form. Fields marked “*” are mandatory and claims will be rejected if not completed. The form should be completed electronically, handwritten claims will be rejected.
 - b. A Commercial Proof of Purchase will be required in case items are rejected.

- 3. A Return Authorisation number will be issued to you via return fax or email.
- 4. Please ensure your returns-
 - a. Conform to the published Fujitsu / Toshiba Warranty Policies, details follow.
 - b. Are shipped in original Fujitsu / Toshiba packaging. Otherwise, please ensure that each item is adequately packaged and protected against physical and electrostatic damage during shipment. (Note: Damaged drives will be rejected by Toshiba).
- 5. For shipping details, refer to your Return Authority Validation Response that will be sent via email once your claim has been validated. All cartons should be marked – Attention: Toshiba Warranty Claims quoting the appropriate, RMA# RMAXXXXXXX.
- 6. Please allow a minimum of 10 working days prior to making enquiries about your Warranty Claim.

Limited Warranty for Fujitsu Storage Products (Drives)

Toshiba America Information Systems, Inc. Storage Device Division (TAIS-SDD) provides the following Limited Warranty on Fujitsu Branded Toshiba Storage Products distributed by Toshiba or through Toshiba's authorised distribution channels:

Toshiba warrants that the Storage Product, from the time of sale through the Limited Warranty period, will function properly under normal use, be free of defects in materials or workmanship, and will conform to the performance specifications applicable to the Product.

All Fujitsu Branded Toshiba Storage Products are subject to the Warranty Exclusions described below. A Fujitsu Branded Toshiba Storage Product found to be defective, or which does not conform to the product specifications, will be repaired or replaced with a new or refurbished product at Toshiba's option.

Proof of purchase may be required to demonstrate eligibility for warranty service.

Warranty Exclusions

Toshiba's Limited Warranty does not apply to a Fujitsu Branded Toshiba Storage Product that has been subjected to physical damage after purchase, caused, for example, by casualty, accident, acts of God or transportation, including: (a) a failure to properly package and ship the product back to Toshiba for warranty service in accordance with Toshiba's then current Packaging and Shipping Guidelines; (b) user's installation, system integration, programming, reinstallation of user operating systems or applications software, systems engineering, relocation, reconstruction of data, or removal of the product or any component (including breakage of a connector, or of pins, seals or other components); (c) service, modification or repair not performed by Toshiba or any data recovery company authorised by Toshiba, or by tampering, use of counterfeit or other non-Toshiba components, assemblies or modules; (d) misuse, unreasonable handling or maintenance, mistreatment, operator error, failure to provide proper supervision or management, including use of cleaning products, or other accessories not approved by Toshiba; (e) environmental conditions (such as excessive heat or other unsuitable physical operating environment), corrosion, staining, electrical work external to the product or failure to provide Electro-Static Discharge (ESD) protection; (f) failure to install the firmware updates or releases available for the product; and (g) such other supplemental exclusions published from time to time online at the Warranty Service Guide (and also available by calling.)

Products whose labels have been defaced, altered, are missing or which no longer contain a legible valid serial number will not be accepted for warranty service. In addition, for the customer's protection, warranty service is not available for products determined to be stolen, scrapped or otherwise removed from normal service.

Toshiba provides no Limited Warranty for products that are purchased as part of a computer system or other electronic device or instrument. Any warranty for these products is provided by the OEM (Original Equipment Manufacturer) as part of that manufacturer's product or system, except as posted from time to time at the Warranty Service Guide page.

If any of the above excluded services are required, they may be available through an Authorised Data Recovery Company at their hourly rates and at terms then in effect.

Repaired or replaced products assume the remainder of the Limited Warranty period applicable to the defective product or ninety (90) days, whichever is longer.
